Saline County Cover Photo Contest Rules

By submitting an entry, you agree to be bound by the following “Official Rules” of the contest:

1) SPONSOR

- a. The contest is sponsored by the Saline County Clerk’s Office.

2) ELIGIBILITY

- a. Open to all residents of Saline County, Missouri
- b. All ages are eligible to participate
 - i. Entrants under the age of 18 must include a completed Parental Consent and Photo Release Form signed by a parent or legal guardian. Submissions without required consent will not be considered.
- c. Immediate family members of the Sponsor or members of their household are not eligible to participate

3) CONTEST TIMELINE

- a. Contest Opens: May 1, 2026
- b. Submission Deadline: May 8, 2026 at 11:59 PM
- c. Public Voting Period: May 11 – May 20, 2026
- d. Winner Announced: May 21, 2026
- e. Winning photo will appear on the cover of the 2025 Saline County Financial Statement

4) HOW TO ENTER

- a. The contest will begin on May 1, 2026. To enter, you must submit your photo and Photo Entry Form to countyclerk@salinecountymo.gov or by walking/mailing in a physical copy to the Clerk’s Office during regular business hours. Minors under 18 years of age will also need to complete a Parental Consent Form. All photos must be received by 11:59pm on May 8, 2026. Late entries will not be accepted. Only one entry per contestant. No entry fee is required to participate in the contest. Any questions can be directed to the Saline County Clerk’s Office at 1-660-886-3331.

5) PHOTO REQUIREMENTS

- a. Must be original work taken by the entrant.
- b. Must represent Saline County, Missouri.
- c. Must not include identifiable individuals without their permission.
- d. Must be submitted in vertical (portrait) orientation suitable for an 8” x 11” publication.
 - i. The Sponsor reserves the right to crop or adjust images for layout purposes.
- e. No watermarks, logos, or added text
- f. To accommodate print quality, photos should be submitted as high-resolution JPG, PNG, TIF, or PDF file types with a **minimum resolution of 300 dpi**. Max 10 MB file size.
- g. The Sponsor may require the original photo of the finalists to be submitted for print quality purposes; therefore, contestants should maintain their original photo.

6) PUBLIC VOTING

- a. The public voting period will begin May 11, 2026 and will end May 20, 2026. Members of the general public may vote for their preferred cover photo among the selected finalists on Facebook by “liking” the photo. Comments will not be counted as votes for the contest. The photo that received the most votes during the voting period will be the winner. Votes are limited to one per photo per Facebook account. The Sponsor reserves the right to remove fraudulent or suspicious activity at its discretion.
 - i. This contest is in no way sponsored, endorsed, administered by, or associated with Facebook.
- b. In the event of a tie between photos the top photos will be reviewed and selected by Saline County Elected Officials. Contestant names will not be presented during the selection process in the event of a tie.

7) VOTING RULES

- a. Finalists are encouraged to tell family and friends about the competition and ask them to participate in voting. Activity deemed to be fraudulent, unfair, or unethical is not permitted and may result in the removal of a photo entry or disqualification of a contestant.

8) VERIFICATION OF WINNER AND FINALISTS

- a. All potential winners and finalists are subject to verification by the Sponsor. A potential winner and first and second runners-up will be notified using the contact information provided on the Photo Entry Form. If the winner and runners-up cannot be verified, the Sponsor will fill the positions with the finalist(s) with the next highest votes from the public voting.

9) CONTEST WINNER AND RUNNERS-UP

- a. The winner’s photo will be used as the official cover of 2025 Saline County, Missouri financial statement. **Saline County information will be added to the cover photo.*
- b. The name and photo of finalists may appear on media outlets such as television, radio, and newspaper and their respective social media platforms.

10) OWNERSHIP OF ENTRIES

- a. The sponsor does not claim ownership to the contest entries. By completing the Photo Entry Form and submitting photo, you are acknowledging that you have read and agree to these Official Rules and release liability. In addition, you agree to grant the Sponsor a non-exclusive, fully paid-up and royalty-free, worldwide license to use, modify, delete from, add to, publicly perform, publicly display, reproduce and translate your photo entry, including without limitation the right to distribute all or part of your photo entry, you agree and consent to the use of your photo, name, and photograph by the Sponsor, its affiliates, subsidiaries, parents, and licensees in connection with the contest and related marketing activities, in any media format or channels now known or hereafter invented, in any and all locations, without any

payment to or further approval from you. You agree that this consent is perpetual and cannot be revoked.

11) REPRESENTATIONS AND WARRANTIES

- a. By submitting an entry, you agree that your entry:
- i. Is your original photo;
 - ii. Does not contain any words or images that are obscene, inappropriate, or defamatory, according to the judgment of the Sponsor;
 - iii. Does not infringe or violate the copyrights, trademarks, rights of privacy, publicity or other rights of any person or entity.
 1. If the entry includes identifiable individuals, the entrant certifies that they have obtained all necessary permissions from those individuals or, if applicable, their parent or legal guardian, for use of their likeness.
 - iv. Does not contain malicious code, such as viruses, timebombs, cancelbots, worms, Trojan horses, and other harmful programs or information.
 - v. Does not and will not violate any law, statute, ordinance, rule, or regulation.
 - vi. Does not feature the likeness of private individuals without the individual's explicit written permission for its use.
 - vii. Does not trigger any reporting or royalty obligation to any third party; and
 - viii. Does not contain any words, symbols, or images that are partisan in nature to any political party, ideological thought, or controversial issue.**

You also agree that the rights that you are granting under these Official Rules do not conflict with any other agreement to which you are a party or have entered, or with any commitments, restrictions, or obligations that you are under to any person or entity.

12) OTHER TERMS AND CONDITIONS

ENTRY CONDITIONS AND RELEASE: By entering the contests, each contestant agrees to:
