Shall the Board of Education of the Miami R-I School District, Missouri, borrow money in the amount of Two Million Dollars (\$2,000,000) for the purpose of providing funds for the site development, construction, equipping, and furnishing of a new gymnasium; to the extent funds are available, complete other repairs and improvements to the existing facilities of the District; and issue general obligation bonds for the payment thereof resulting in an estimated increase to the debt service property tax levy of \$0.8800 per one hundred dollars of assessed valuation?

If this proposition is approved, the adjusted debt service levy of the School District is estimated to increase from \$0.0000 to \$0.8800 per one hundred dollars of assessed valuation of real and personal property.
